Move-ups

MOVE-UPS close at 6:00 pm CDT, Tuesday, September 24. Move-ups may be sent by regular mail or email to the Trial Secretary. If an email address is provided with your entry, an email confirmation of the move-up will be sent.

Change of Entry

As described in Chapter 1, Section 21 of the Regulations for Agility Trials, a dog which is entered in a Novice A class for which it is not eligible may be moved to Novice B. In addition, if notification has been received in writing from the AKC after closing that a dog is not eligible for a class entered, the dog may be moved to the correct class. The request for the move must be made at least 30 minutes prior to the start of the trial. If a VMO or Field Representative at a trial measures a dog into a height other than what they entered, the entry may be changed from Regular to Preferred or from Preferred to Regular, as long as the dog has not run any classes that day. If the dog has already run, the change may be made for the next trial day(s). The exhibitor must provide the Trial Secretary the AKC Agility Measurement Form when requesting the class change.

Electronic Timing

Electronic timing will be used at these trials.

Volunteer Measuring Official

The judge is a VMO. If your dog does not have a height card, it will need to be officially measured.

Trial Information

The site will be open at **7:00 am on Tuesday, October 1.** Trial hours are 7:00 am until 30 minutes after the completion of judging. Ring size: 85' x 110'.

The building is air-conditioned. Please bring crates and chairs. All crates must be on mats, carpet or some other material that will protect the floor.

Concessions are available at the trial site. No outside food or beverage is allowed on Purina Farms property. Violators will be reported to the AKC.

Notice to Exhibitors

- The <u>safety of the dogs</u> is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all obstacles safely.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.

The Australian Cattle Dog Club of America may cancel this event in extreme weather conditions.

- Entry fees will not be refunded if the trial cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
- Since <u>bitches in season</u> are not allowed to compete in AKC Agility Trials, the club will refund all but \$7.00 of the entry fee for bitches unable to compete for that reason. The Trial Secretary must receive a <u>veterinarian's letter</u> at least 30 minutes prior to the start of the trial.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committees, be asked to leave the trial site. In such case, no refund of any fees paid will be made.
- <u>All dogs must be on leash or crated</u> at all times except when in the ring or when in the designated agility warm-up area.
- Exhibitors are responsible for being at the ring gate when it is their turn to run. The judge need not wait for any dog holding up a class. The Australian Cattle Dog Club of America has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.

Entries must be made on Official AKC entry forms or copies and <u>must include the signed</u> <u>Agreement and Rules</u>. <u>Junior Handlers</u> must enter their JH# and complete back of form. Include only AKC titles on entries.

Owners are responsible for errors in making out entry forms, regardless of whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date. No refunds for duplicate entries.

Dogs under 4 months of age are not permitted on the show grounds of AKC Agility Trials.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites and any communicable diseases and have appropriate vaccinations.

Returned checks do not constitute a valid entry fee. There is a \$30 returned check fee.

Checks for withdrawn entries will be shredded. No checks will be returned.

Refunds will not be processed for overpayments of less than \$5.00.

- Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement.
- The Australian Cattle Dog Club of America does not agree to arbitrate claims as set forth on the Official AKC Entry Form for this event.
- The Australian Cattle Dog Club of America, its Board and Members, and Purina Event Center and its employees will not be liable for any loss or injury which may be sustained through disappearance, loss, theft, communicable disease, parasites, injury and/or death of dogs entered in this event.

Dogs cannot be left in the Purina Farms Event Center or the outdoor grooming tent overnight. All crates must be marked with a contact name and phone number.

Electronic timing will be used at this trial.

No one is permitted anywhere that is marked "Employees Only" and/or "No Admittance." These are separate divisions of Purina and not part of the show grounds.

No baby strollers are allowed inside the building.

No firearms are allowed on Purina property.

Directions

From North/East/South: Take I-44 to Gray Summit/Hwy 100 Exit 253. Turn east on Hwy 100. After approximately ½ mile, turn left on MM (in front of gas station). Entrance to Purina Farms is approximately 0.5 mile on left, just past the herding field.

In the case of a continued tie, a run off will be conducted; High in Trial will be awarded to the dog with the highest score, with greatest number of seconds under SCT as the tiebreaker.

High in Trial Standard will be awarded to the dog in Regular Master or Excellent Standard with the highest score, with the first tiebreaker greatest number of seconds under SCT. In the case of a continued tie, a run off will be conducted; High in Trial will be awarded to the dog with the highest score, with greatest number of seconds under SCT as the tiebreaker.

High in Trial JWW will be awarded to the dog in Regular Master or Excellent JWW with the highest score, with the first tiebreaker greatest number of seconds under SCT. In the case of a continued tie, a run off will be conducted; High in Trial will be awarded to the dog with the highest score, with greatest number of seconds under SCT as the tiebreaker.
