### Notice to Exhibitors

THE TRIAL SITE will be available at 7:00 am. Judging will start at 8:00 am.

The building will be available for set up on Friday, Oct 27 from 5:00 pm - 7:30 pm.

CRATING in designated areas only. CRATE SPACE IS LIMITED. X-pens will not be allowed in the building. Dogs must be removed from the Trial site immediately following the conclusion of the judging on Sunday, Oct 29. There will be no space for un-entered dogs. No RV or Overnight parking allowed at the Trial Site.

Belle-City Kennel Club, Inc. and its members assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.

ENTRY FORMS MUST BE SIGNED at the bottom by the owner or the owner's duly authorized agent, otherwise entry cannot be accepted.

CHANGES, ADDITIONS OR CORRECTIONS to entry forms must be received in writing or by e-mail prior to the close of entries. Those received by telephone are not acceptable.

ERRORS ON ENTRY BLANKS. Owners and handlers are responsible for errors in making out entry forms and no entry fee will be refunded in event of such error or cancellation of entries after the published closing date. Please print plainly or type all information on your entry to help avoid errors.

MAKE ALL CHECKS AND MONEY ORDERS PAYABLE TO Belle-City Kennel Club, Inc.

A RECORDING FEE of 50 cents and \$3.00 AKC Event Service Fee are required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. This Recording Fee is to be collected by the show-giving club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, the recording fee is to be collected on the first entry only (AKC Dog Show Rules, Chapter 11, Section 2). A RECORDING FEE of \$3.50 is required for the first entry and \$3.00 for each additional entry at any Licensed or Member Club Rally Trial.

Canadian Exhibitors must submit entries with checks drawn on U.S. accounts or with international money orders in U.S. funds.

NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.

ENTRY FEES shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by the action of the Event Committee. NO ENTRY FEES will be refunded if the Trial cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of Belle-City Kennel Club.

Checks for canceled entries will be shredded; not checks will be returned.

POST DATED CHECKS AND RETURNED CHECKS do not constitute a valid entry fee. The Secretary will add a \$15 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis.

THERE WILL BE NO REFUND FOR DUPLICATE ENTRIES.

ACKNOWLEDGEMENT OF ENTRIES will be made as soon as practicable after entries close with confirmation and judging programs. Should such acknowledgement not be received by exhibitor within a reasonable amount of time, please notify Trial Secretary.

JUDGES ARE NOT REQUIRED TO WAIT FOR DOGS. Owners or agents alone are responsible for the presence of their dogs in the ring at their scheduled time. Judges will adhere as closely as possible to the judging schedule.

ALL DOGS PRESENT MUST BE HELD ON LEASH BY THE HANDLER OR CONFINED TO THEIR CRATES except when being judged.

Dogs may not be on Flexi-Leads or long leads while in the building.

EXHIBITORS SHOULD FOLLOW THEIR VETERINARIANS' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Every effort will be made to accommodate handlers with multiple dogs in the same class. Food will be available on site.

All exhibitors must be responsible for cleaning up after their dogs on the motel and trial grounds. Motels require that dogs be crated when unattended. It is expected that exhibitors will clean up immediately after their own dogs and strongly encourage others to do the same.

All owners/exhibitors should be aware that the entire motel grounds are considered within the trial grounds. You will be responsible for all damage to your room and may be subject to disciplinary action in accordance with the rules of the AKC. Any abuse of the grounds will be brought to the attention of the trial-giving club and its Trial Committee. Any exhibitor's entries may be refused for previous misuse of the motel facilities. This is an AKC supported measure.

FROM THE EAST: I-64 to Hwy 159. South on 159 to Hwy 161. Turn left (east) on Hwy 161 to Lebanon Ave (first stoplight). Turn left on Lebanon Ave to West Blvd. Turn right on West Blvd. Turn left on Eastview Dr.

FROM THE WEST: I-64 to Hwy 159. South on 159 to Hwy 161. Turn left (east) on Hwy 161 to Lebanon Ave (first stoplight). Turn left on Lebanon Ave to West Blvd. Turn right on West Blvd. Turn left on Eastview Dr.
