Note to Exhibitors

The Show Site will be available to exhibitors on Friday, April 9, 2010. Crating and grooming in designated areas only, under the tent below the RV area. There is electric access. Electric is also available on the RV lot. Limited electric is available in the lower parking area.

A Booster Bath will be available for dog bathing.

Refund of entries for bitches entered in Obedience or Rally that come in season after closing date of this show may be obtained by sending a veterinarian's certificate to the Show Secretary by April 12, 2010.

Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Neither the club nor its Show Secretary will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.

All trophies must be claimed the day of the show. None will be mailed. The club reserves the right to substitute a prize of equal or greater value. All prizes are offered by the Golden Retriever Club of Greater St Louis through the generosity of its members and friends.

A complete list of contributors will be printed in the catalog.

Requests for move-ups must be presented to the Show Secretary at least 30 minutes before the start of the show and must be in writing.

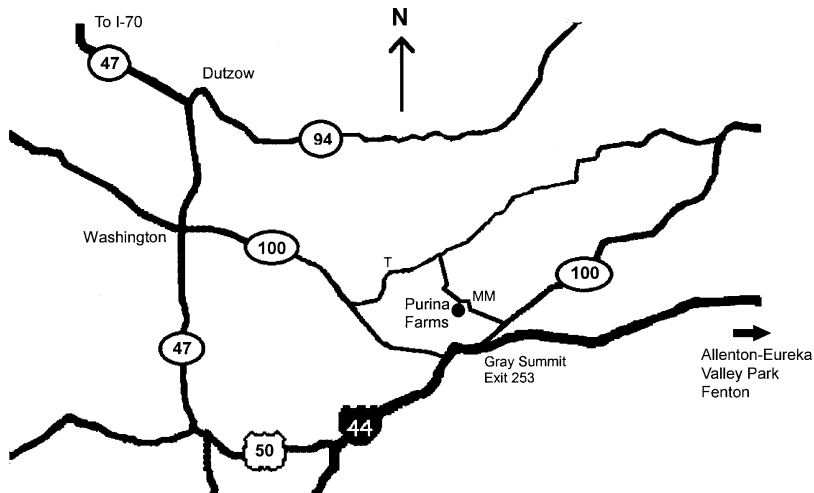

Directions

From East/North/South: Take I-44 to Gray Summit/Hwy 100 Exit 253. Turn north (east) on Hwy 100. After approximately ½ mile, turn left on Hwy MM. Entrance to Purina Farms is approximately 1 mile on the left.

From West: Take I-70 to Hwy 47, exit 193. Take Hwy 47 south to Hwy 100. Continue on 100 to I-44 east. Take I-44 east one exit, then exit at Gray Summit. Follow directions as above.

NOTE: THERE IS CONSTRUCTION ON I-44 NEAR EXIT 253.

You will be responsible for all damage to your room and may be subject to disciplinary action in accordance with the rules of the AKC. Any abuse of the grounds will be brought to the attention of the show-giving club and its Show Committee. Any exhibitor's entries may be refused for previous misuse of the motel facilities. This is an AKC supported measure.
