Move-ups

For the Friday, Sep 30, trial: MOVE-UPS close at 6:00 pm CDT, Sep 26. Move-ups may be sent by regular mail or email to the Trial Secretary. If an email address is provided with your entry, an email confirmation of the move-up will be sent.

For the Saturday, Oct 1 and Sunday, Oct 2 trials: MOVE-UPS close 30 minutes after the end of the trial on Friday, Sep 30 and Saturday, Oct 1 respectively and must be submitted at the trial.

Change of Entry

As described in Chapter 1, Section 21 of the Regulations for Agility Trials, a dog which is entered in a Novice A class for which it is not eligible may be moved to Novice B. In addition, if notification has been received in writing from the AKC after closing that a dog is not eligible for a class entered, the dog may be moved to the correct class. The request for the move must be made at least 30 minutes prior to the start of the trial.

Electronic Timing

Electronic timing will be used at these trials.

AKC Height Cards

There will be a VMO at these trials.

Notice to Exhibitors

The safety of the dogs is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all obstacles safely.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.

Greater St Louis Agility Club may cancel this event in extreme weather conditions.

Entry fees will not be refunded if the trials cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

Since bitches in season are not allowed to compete in AKC Agility Trials, the club will refund all but \$5.00 of the entry fee per day for bitches unable to compete for that reason. The Trial Secretary must receive written notification of such a claim for refund by letter hand-delivered, emailed, or postmarked before the trial commences.

The club will refund all but \$10.00 of the entry fee per day for injured or ill dogs. Written request for a refund must be made to the Trial Secretary prior to the start of the first trial day and a veterinarian's letter must be provided within one week of the trial.

The club will refund all but \$10.00 of the entry fee per day in the form of a club voucher for exhibitors who are absent due to a death in the immediate family.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

All dogs must be on leash or crated at all times except when in the ring or when in the designated agility warm-up area.

Exhibitors are responsible for being at the ring gate when it is their turn to run. The judge need not wait for any dog holding up a class. Greater St Louis Agility Club has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.

Dogs under 4 months of age are not permitted on the show grounds of AKC Agility Trials.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites and any communicable diseases and have appropriate vaccinations.

Greater St Louis Agility Club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

Returned checks do not constitute a valid entry fee. There is a \$25 returned check fee.

No refunds will be issued for overpayment of less than \$12.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement.

The front doors are to be used to enter/exit the facility. Side doors are for emergency use only.

Trial Information

General crate setup starts FRIDAY at 6:30 am.

Ring size: 85' x 110' each (2 rings).

The arena is air-conditioned with indoor restrooms and bleacher seating. Please bring crates and water for your dogs and clean up supplies. Xpens will be allowed for 2 or more dogs but should be restricted to the minimum size required for crating.

No electrical devices are allowed due to overburdening of the electrical system. Battery-operated devices are welcome.

Matt McDaniel's food truck will be the trial site. Exhibitors may bring their own food into the building.

All exhibitors should be aware that the entire motel grounds and RV sites are considered within the trial grounds. All exhibitors are responsible for cleaning up after their dogs on the motel, RV and trial grounds.

Motels require that dogs be crated when unattended. Any damages to motels, RV sites or the trial site or abuse of the grounds can result in disciplinary action by the Event Committee. Directions

Prizes and Awards

Ribbons will be awarded to First Place through Fourth Place in each jump height in each class. Qualifying ribbons will be awarded to all dogs receiving a qualifying score. Dogs must qualify to receive placement ribbons.

- 1st place Blue
- 2nd place Red
- 3rd place Yellow
- 4th place White
- Qualifying Green

A MACH rosette and bar will be awarded to any dog finishing a MACH title at these trials. A PACH rosette and bar will be awarded to any dog finishing a PACH title at these trials. A PAX rosette will be awarded to any dog finishing a PAX title at these trials. A new title rosette will be awarded to any dog finishing a title at these trials. Dogs qualifying in both Master Standard and Master JWW in the same trial will receive a "Double-Q" award (value less than \$1). Dogs qualifying in Master Standard, Master JWW and Master FAST in the same trial will receive a "Triple-Q" award (value less than \$1). Junior handlers earning a qualifying leg will receive rosettes.
