Move-ups

For the Friday, Sep 25 trial: MOVE-UPS close at 6:00 pm CDT, Sep 21. Move-ups may be sent by regular mail or email to the Trial Secretary. If an email address is provided with your entry, an email confirmation of the move-up will be sent.

For the Saturday, Sep 26 and Sunday, Sep 27 trials: MOVE-UPS close 30 minutes after the end of the trial on Friday, Sep 25 and Saturday, Sep 26 respectively and must be submitted at the trial.

Mailed/emailed moveups close at 6:00 pm CDT, Monday, Sep 21.

Change of Entry

As described in Chapter 1, Section 21 of the Regulations for Agility Trials, a dog which is entered in a Novice A class for which it is not eligible may be moved to Novice B. In addition, if notification has been received in writing from the AKC after closing that a dog is not eligible for a class entered, the dog may be moved to the correct class. The request for the move must be made at least 30 minutes prior to the start of the trial. If a VMO or Field Representative at a trial measures a dog into a height other than what they entered, the entry may be changed from Regular to Preferred or from Preferred to Regular, as long as the dog has not run any classes that day. If the dog has already run, the change may be made for the next trial day(s). The exhibitor must provide the Trial Secretary the AKC Agility Measurement Form when requesting the class change.

Crate Space Signup

The link for crate space reservations will be sent out in the next few days. Anyone entered more than 1 day should reserve a crate space.

AKC Height Cards

The judge, Laura English, is a VMO and WILL be measuring dogs at the trial in the center room.

Text Notifications

We will be using the Remind App to keep exhibitors informed during the trial. Informational text messages alerting exhibitors to the current status of the trial such as: class currently running, estimated time before next class starts, course builds, walkthroughs, etc. will be sent via the Remind App.

Trial Information

The club will start setting up at 6 pm on Thursday. Only those who help with setting and moving equipment will be allowed to set up crates on Thursday.

The building will open at 6:30 am on Friday, Saturday and Sunday.

Trial hours are 7:00 am to 30 minutes after the completion of judging.

Ring size: 85' x 110' each (2 rings).

The arena is air-conditioned with indoor restrooms and bleacher seating. Please bring crates and water for your dogs and clean up supplies. Xpens will be allowed for 2 or more dogs but should be restricted to the minimum size required for crating.

No electrical devices are allowed due to overburdening of the electrical system. Batteryoperated devices are welcome.

Please use the designated outside areas to potty your dog.

Food

The Sports Academy will have the cafe open for lunch from 11:00 am to 2:00 pm.

Prizes and Awards

Ribbons will be awarded to First Place through Fourth Place in each jump height in each class
Qualifying ribbons will be awarded to all dogs receiving a qualifying score. Dogs must qualifying score.

An AGCH rosette will be awarded to any dog finishing an AGCH title at these trials. A MACH rosette and bar will be awarded to any dog finishing a MACH title at these trials. A PACH rosette and bar will be awarded to any dog finishing a PACH title at these trials. A new title rosette will be awarded to any dog finishing a title at these trials. Dogs qualifying in both Master Standard and Master JWW in the same trial will receive a "Double-Q" award (value less than \$1). Dogs qualifying in Master Standard, Master JWW and Master FAST in the same trial will receive a "Triple-Q" award (value less than \$1). Junior handlers earning a qualifying leg will receive rosettes.

Notice to Exhibitors

- The <u>safety of the dogs</u> is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all obstacles safely.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.
- Greater St Louis Agility Club may cancel this event in extreme weather conditions.
- Entry fees will not be refunded if the trials cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
- Since <u>bitches in season</u> are not allowed to compete in AKC Agility Trials, the club will refund all but \$5.00 of the entry fee per day for bitches unable to compete for that reason. The Trial Secretary must receive <u>written notification</u> of such a claim for refund by letter hand-delivered, emailed, or postmarked before the trial commences.
- The club will refund all but \$10.00 of the entry fee per day for <u>injured or ill dogs</u>. Written request for a refund must be made to the Trial Secretary prior to the start of the first trial day and a veterinarian's letter must be provided within one week of the trial.
- The club will refund all but \$10.00 of the entry fee per day in the form of a club voucher for exhibitors who are absent due to a death in the immediate family.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.
- <u>All dogs must be on leash or crated</u> at all times except when in the ring or when in the designated agility warm-up area.
- Exhibitors are responsible for being at the ring gate when it is their turn to run. The judge need not wait for any dog holding up a class. Greater St Louis Agility Club has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.
- Entries must be made on Official AKC entry forms or copies and <u>must include the signed</u>
 Agreement and Rules. Junior Handlers must enter their JH# and complete back of form.
- All owners of mixed breed dogs must first obtain an AKC Canine Partners listing number before they may enter an AKC Agility event. The dog's breed name should be entered as "All American Dog". The dog's listing number must be entered on the entry form and "AKC No." checked.
- Owners are responsible for errors in making out entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date. No refunds for duplicate entries.
- Dogs under 4 months of age are not permitted on the show grounds of AKC Agility Trials.
- Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites and any communicable diseases and have appropriate vaccinations.
- Greater St Louis Agility Club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.
- Returned checks do not constitute a valid entry fee. There is a \$25 returned check fee.
- No refunds will be issued for overpayment of less than \$12. Checks for canceled entries will be shredded.
- Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement.
- The front doors are to be used to enter/exit the facility. Side doors are for emergency use only. Electronic timing will be used at these trials.

All exhibitors must be responsible for cleaning up after their dogs on the motel, RV and trial grounds. Motels require that dogs be crated when unattended. Any damages to motels, RV sites or the trial site can result in disciplinary action by the Event Committee. It is expected that exhibitors will clean up immediately after their own dogs and strongly encourage others to do the same.

All owners/exhibitors should be aware that the entire motel grounds and RV sites are considered within the trial grounds. Directions

From the North: Take I-55 South to I-270 West. From the East: Take I-70 West to I-270 West.

From both directions: Proceed on 270 West to Illinois Hwy 157 at exit 9. Turn Left off I-270 and take 157 South to The Game Drive, approximately ½ mile on the right (at the gas station, across from the Hampton Inn).

From the South: Take I-55 North to St Louis. Stay on I-55 into Illinois to I-270 North/East.

From the West: Take I-70 East, I-64 East or I-44 East to I-270 North/East.

From both directions: Proceed on I-270 East to Illinois Hwy 157 at exit 9. Turn Right off I-270 and take 157 South to The Game Drive, approximately ¼ mile on the right (at the gas station, across from the Hampton Inn).

NOTE: I-255 in IL from Route 15 (southern end) to I-64 (northern end) is closed.
