Limit of 10 dogs per envelope.

All entries must be submitted on official AKC Agility entry forms, one dog per entry form. Photocopies of entry forms without the AKC Agreement are not acceptable. Unsigned, incomplete, or illegible entries are not acceptable.

If you would like confirmation that your entry was received before the trial has closed, please include your email address or enclose a self-addressed stamped postcard.

Checks for withdrawn entries will be shredded.

Entries cannot be changed once the trial has closed. Please check your entries!

Random Draw

Entries for the random draw will be accepted from Monday, November 30 at 8 am CST to Monday, December 14 at 6 pm CST. The drawing will be held on Monday, December 14 at 7 pm CST at the secretary's office, 632 N Forest Ave, Webster Groves, MO 63119.

A limited number of spaces will be set aside for workers by the Event Committee. If you would like to be considered for the workers' draw list, you must check the WORKER box on the entry form (or write it in if using a different form). Those entering online can email the trial secretary directly.

"After Closing" Waiting List

A waiting list (30 run maximum each day) will be maintained for these trials once they have closed on Jan 20. The waiting list will be active until its deadline — Monday, Feb 1, 6:00 pm CST. Any runs that are entered in these trials at closing and pulled before the waiting list deadline will be replaced, if possible, by runs in order on the waiting list, and the exhibitor will be reimbursed in full. If a run is pulled but cannot be replaced, the exhibitor will not receive a refund and the dog will be considered absent for the run. Entry fees for runs on the waiting list that do not get into the trial by the waiting list closing date will be refunded in full.

Obstacles

Obstacles will conform to the requirements in the current edition of the AKC Regulations for Agility Trials.

Dogs Eligible to Enter

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/ Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number, or are approved Foundation Stock Service (FSS) breeds.

Dogs with a PAL/ILP number or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Dogs should be physically sound. Dogs that are blind, bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance are not eligible to compete. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Rules Applying to Registration and Discipline for the listing of registerable breeds that may participate.

Wherever the word "dog" is used in these regulations, it includes both sexes.

Trial Limits Explained

Due to the restrictions on the number of people allowed in the building, this trial will be divided into 4 GROUPS for entries and a limit of 40 handlers per GROUP will be allowed. Those handlers and dogs will be allowed to stay in the building and run both their STD and JWW runs back to back.

Group 1 will be all Open/Novice dogs. Group 2 will be M/X 4",8",12", and 16" dogs. Group 3 will be M/X 20", 24" and 24C" dogs. Group 4 will be Premier STD (Fri). Premier JWW (Sat) and T2B (Sun).

There will be a separate wait list for each group if the 40 handler limit is reached. There is no limit on how many dogs one handler may run in their group or how many groups a handler is in.

All dogs competing in agility must **possess** an official AKC Jump Height Card. **You are not** required to show your height card or send a copy with your entry. You <u>are required</u> to mark on your entry form if your dog needs to be measured. For more information please visit http://www.akc.org/events/agility/jump_height_card.cfm.

Move-ups

For the Friday, Feb 5, trial: MOVE-UPS close at 6:00 pm CST, Feb 1. Move-ups may be sent by regular mail or email to the Trial Secretary. If an email address is provided with your entry, an email confirmation of the move-up will be sent.

For the Saturday, Feb 6 and Sunday, Feb 7 trials: MOVE-UPS close 30 minutes after the end of the trial on Friday, Feb 5 and Saturday, Feb 6 respectively and must be submitted at the trial.

Mailed/emailed moveups close at 6:00 pm CST, Monday, Feb 1.

NOTE: Moveups from Open to Excellent may be subject to handler limits in the building.

Change of Entry

As described in Chapter 1, Section 21 of the Regulations for Agility Trials, a dog which is entered in a Novice A class for which it is not eligible may be moved to Novice B. In addition, if notification has been received in writing from the AKC after closing that a dog is not eligible for a class entered, the dog may be moved to the correct class. The request for the move must be made at least 30 minutes prior to the start of the trial. If a VMO or Field Representative at a trial measures a dog into a height other than what they entered, the entry may be changed from Regular to Preferred or from Preferred to Regular, as long as the dog has not run any classes that day. If the dog has already run, the change may be made for the next trial day(s). The exhibitor must provide the Trial Secretary the AKC Agility Measurement Form when requesting the class change.

Trial Information

Crating information and set-up time for Thursday will be announced after closing. Trial hours are 7:00 am to 30 minutes after the completion of judging. Ring size: 90' x 95' (1 ring). Electronic timing will be used at these trials. The building is climate-controlled. Please bring chairs and crates and water for your dogs. Dogs may not be left in the building overnight.

Changes Effective January 1, 2020

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A **separate entry form must be submitted** when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

Fix and Go On (FNG)

As of January 1, 2020, Fix and Go On will be offered on a one-year pilot basis in order to give AKC time to evaluate its impact. FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle and then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score.

Fix and Go On is not pre-entered; rather, it occurs during the course of the run.

For Exhibition Only (FEO) is not offered at this trial.

Prizes and Awards

Ribbons will be awarded to First Place through Fourth Place in each jump height in each class. Qualifying ribbons will be awarded to all dogs receiving a qualifying score. Dogs must qualify to receive placement ribbons.

An AGCH rosette will be awarded to any dog finishing an AGCH title at these trials. A MACH /PACH rosette and bar will be awarded to any dog finishing a MACH/PACH title at these trials. Dogs qualifying in both Master Standard and Master JWW in the same trial will receive a "Double-Q" award (value less than \$1). Junior handlers earning a qualifying leg will receive rosettes.

Additional Notice

As per AKC regulations, pinch/prong collars and electrical collors (dummy or not) and special training collars are not allowed anywhere on the trial grounds. This includes high frequency devices.

Excessively or continuously barking dogs will not be tolerated.

Reactive dogs should not be crated by doorways or other high traffic areas.

Laser pens are not allowed inside the building.

FLEXI-LEADS ARE NOT ALLOWED TO BE USED IN THE BUILDING. You must go 10 feet from the building before releasing a Flexi-lead. Keep your dogs close to you coming and going through doors plus while you are walking inside the building.

Notice to Exhibitors

- The <u>safety of the dogs</u> is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all obstacles safely.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.
- Greater St Louis Agility Club may cancel this event in extreme weather conditions.
- Entry fees will not be refunded if the trials cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
- Since <u>bitches in season</u> are not allowed to compete in AKC Agility Trials, the club will refund all but \$5.00 of the entry fee per day for bitches unable to compete for that reason. The Trial Secretary must receive <u>written notification</u> of such a claim for refund by letter handdelivered, emailed, or postmarked before the trial commences.
- The club will refund all but \$10.00 of the entry fee per day for <u>injured or ill dogs</u>. Written request for a refund must be made to the Trial Secretary prior to the start of the first trial day and a veterinarian's letter must be provided within one week of the trial.
- The club will refund all but \$10.00 of the entry fee per day in the form of a club voucher for exhibitors who are absent due to a death in the immediate family.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.
- <u>All dogs must be on leash or crated</u> at all times except when in the ring or when in the designated agility warm-up area.
- Exhibitors are responsible for being at the ring gate when it is their turn to run. The judge need not wait for any dog holding up a class. Greater St Louis Agility Club has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.
- Entries must be made on Official AKC entry forms or copies and <u>must include the signed</u> Agreement and Rules. Junior Handlers must enter their JH# and complete back of form.
- All owners of mixed breed dogs must first obtain an AKC Canine Partners listing number before they may enter an AKC Agility event. The dog's breed name should be entered as "All American Dog". The dog's listing number must be entered on the entry form and "AKC No." checked.
- <u>Owners are responsible for errors in making out entry forms</u>, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. <u>Errors in entries made by the exhibitor cannot be corrected after the closing date</u>. No refunds for duplicate entries.
- Dogs under 4 months of age are not permitted on the show grounds of AKC Agility Trials.
- Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites and any communicable diseases and have appropriate vaccinations.
- Greater St Louis Agility Club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.
- Returned checks do not constitute a valid entry fee. There is a <u>\$25 returned check fee</u>.
- No refunds will be issued for overpayment of less than \$12. Checks for canceled entries will be shredded.
- Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement.
- All exhibitors must comply with WestInn Kennels rules. The current fine schedule for soiling the turf at WestInn Kennels is posted at http://www.labtestedsecretary.com.

COVID-19 Notice to Exhibitors

* Please read carefully *

- To maintain a good traffic flow while maintaining adequate physical distancing, the main double doors will be entry only. The north side door will be an exit door.
- Exhibitors will be allowed to stay in the building during their classes with the schedule listed and the number of runs (and people) allowed at this trial. However, the current state and local policies will dictate how many people will be in the building at any given time. No spectators or family members will be allowed in the building (except a family member for junior handlers).
- Masks (which you must provide) will be required while in the building at all times, including while you are running your dog. Masks must cover your nose and mouth.
- There will be a 6' boundary set around the Gate Steward, Trial Secretary, Judge's Table and the Timer and Scribe table. Please respect these boundaries. ONLY the Gate Steward will be allowed to check dogs in, move dogs, etc.
- Entry and Exit to the agility ring will be by swing gates, covered with a disinfectant-soaked towel.
- Ring crew workers will provide their own chairs. The jump bars will be disinfected during worker changes.
- The leash runner will have a grabber to move the leash; the grabber will be cleaned between workers. You may choose to wear your leash or put it in your pocket instead of leaving it for the leash runner.
- No printed course copies will be distributed. We will have a few posted in the building so that you can take a picture of them. The trial secretary will also post them at http:// www. labtestedsecretary.com the night before each trial and notify everyone by email. She will also post the running order, judge's briefing, trial chair's briefing and results. There will be no group judge's briefing, except for the Novice classes to answer any of their questions. The judge will be available during the trial to answer any questions.
- No food is available at the trial site. No MACH/PACH parties or other group food sharing may be held at this trial.
- Our awards chairperson will prepare ribbons after the completion of the class. NO SELF SERVE will be allowed for ribbons.
- One person will be allowed in each bathroom at a time. Bathrooms are unisex.
- People who are not feeling well and contact trial secretary at least 30 minutes before the start of the trial will be given the same refund as an injured/sick dog. No doctor's note is required. We will automatically cancel the following days runs also. You will receive that same refund for each of the remaining days to get over being sick. PLEASE, STAY HOME AND KEEP EVERYONE SAFE. People who are obviously sick and attend the trial may be asked to leave with NO REFUND.
- The Event Committee has the right and ability to amend the premium as to the changing guidelines due to COVID-19 (CORONAVIRUS).
- In the event we are unable to hold this trial due to changing state COVID -19 guidelines and need to cancel after the trial has closed, we will shred all checks.
- Greater St. Louis Agility Club is doing all we can to make this trial safe, and to comply with state and CDC guidelines; however, we can not guarantee your safety and good health. Handlers whose dogs measure into the 8" through 20" regular jump height divisions may opt to enter in a higher or 24-choice height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs who measure into the 24" regular jump height division may not enter 24-choice. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine Partners ProgramSM may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
