"After Closing" Waiting List

This trial has an "after-closing" waiting list which will be active until Monday, April 11, 6:00 pm CDT. Any dogs that are entered in these trials at closing and pulled before the waiting list deadline will be replaced, if possible, by dogs in order on the waiting list, and the exhibitor will be reimbursed in full. If a dog is pulled but cannot be replaced, the exhibitor will not receive a refund and the dog will be considered absent for the trials. Entry fees for dogs on the waiting list that do not get into the trial by the waiting list closing date will be refunded in full.

Move-ups

For the Friday, April 15, trial (or the first trial day entered): MOVE-UPS close at 6:00 pm CDT, Monday, April 11. For the Saturday, April 16 and Sunday, April 17, trials: MOVE-UPS close 30 minutes after the end of the trial on Friday, April 15 and Saturday, April 16 respectively. Move-ups may be sent by regular mail or email to the Trial Secretary. If an email address is provided with your entry, an email confirmation of the move-up will be sent.

Electronic Timing

Electronic timing will be used at these trials.

VMOs

There will be VMOs available to measure dogs at this trial.

Trial Information

The building is available to exhibitors at 7:30 pm on Thursday, April 14. Only those people involved in ring set-up will be permitted in the building before that time.

Trial hours are 7:00 am to 1 hour after the completion of judging.

Ring size: 85' x 110' each (2 rings).

The arena is air-conditioned with indoor restrooms and bleacher seating. Please bring crates and water for your dogs and clean up supplies. Xpens will be allowed for 2 or more dogs but should be restricted to the minimum size required for crating.

No electrical devices are allowed due to overburdening of the electrical system. Batteryoperated devices are welcome.

Food service is available at the trial site. Food from outside restaurants (eg, McDonalds) is not permitted in building.

Prizes and Awards

Ribbons will be awarded to First Place through Fourth Place in each jump height in each class. Qualifying ribbons will be awarded to all dogs receiving a qualifying score. Dogs must qualify to receive placement ribbons.

All dogs entered in this trial will received one plush toy (value \$1-\$3). A MACH ribbon and bar will be awarded to any dog finishing a MACH title at these trials. A PAX ribbon and bar will be awarded to any dog finishing a PAX title at these trials. A new title ribbon will be awarded to any dog finishing a title at these trials. Dogs qualifying in both Excellent B Standard and Excellent B JWW at the same trial will receive a "Double-Q" award (value less than \$1). Junior handlers earning a qualifying leg will receive rosettes.

Notice to Exhibitors

- The <u>safety of the dogs</u> is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all obstacles safely.
- <u>Entry fees will not be refunded</u> in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.
- Greater St Louis Agility Club may cancel this event in extreme weather conditions.
- Entry fees will not be refunded if the trials cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
- Since <u>bitches in season</u> are not allowed to compete in AKC Agility Trials, the club will refund all but \$10.00 of the entry fee per day for bitches unable to compete for that reason. The Trial Secretary must receive <u>written notification</u> of such a claim for refund by letter hand-delivered, emailed, or postmarked before the trial commences.
- The club will refund all but \$10.00 of the entry fee per day for <u>injured or ill dogs</u> in the form of a club voucher. Written request for a refund must be made to the Trial Secretary prior to the start of the first trial day and a veterinarian's letter must be provided within one week of the trial.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.
- All dogs must be on leash or crated at all times except when in the ring or when in the designated agility warm-up area.
- Exhibitors are responsible for being at the ring gate when it is their turn to run. The judge need not wait for any dog holding up a class. Greater St Louis Agility Club has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.
- Dogs under 6 months of age are not permitted on the show grounds of AKC Agility Trials.
- Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites and any communicable diseases and have appropriate vaccinations.
- Greater St Louis Agility Club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.
- Returned checks do not constitute a valid entry fee. There is a \$25 returned check fee. No refunds will be issued for overpayment of less than \$12.
- Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement.
