Transfer Information

Moveups/Transfers will be allowed according to AKC Regulations, provided that the written request is received at least 30 minutes prior to the start of the show. Email notice is acceptable.

Jump Height Order

Obedience and Rally classes will be run short-to-tall both days.
Every effort will be made to accommodate handlers with multiple dogs in the same class.

Show Information

The building will be available to exhibitors on Friday, March 22 from 3:00 p.m. to 7:00 pm.
The building will open at 7:00 am on Saturday and 6:30 am on Sunday.

Crates must be stacked. No ex-pens will be allowed in the building.

The conformation/sweeps ring will be on the rubber flooring.
Obedience and rally rings will be on the turf.

All crating and grooming will be on the rubber flooring.

Notice to Exhibitors

No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Entries will not be accepted without fees and signatures.

Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from competition by action of Event Committee. No entry fees will be refunded if the show cannot open or be completed because of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, acts of God or other acts beyond the control of the Club.

Owners are responsible for errors in making out entry forms whoever may make such errors. No entry fee will be refunded in the event of such errors.

There will be no refund for duplicate entries. Every effort to find all duplicate entries will be made; however, if the entry has been processed, no refund will be made

Move-ups/transfers will be allowed in all classes per AKC Regulations. The request for a move-up/transfer must be in writing and presented to the show secretary at least 30 minutes prior to the start of each show/trial.

Dogs need not be at the show until the scheduled time for judging. Dogs no longer needed for further judging will be excused. Dogs must be ready for judging. Neither the club nor its Show Secretary will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings. Dogs allowed in the rings during judging only.

Entry fees, less \$5.00 per entry, will be refunded for bitches in season entered in obedience or rally provided that a written request from the owner is provided to the Event Secretary at least 30 minutes prior to the start of the trial. Written verification of a veterinarian must be received no later than March 26, 2019.

Returned checks do not constitute a valid entry fee. The Club will add a \$35.00 collection fee to the amount of each returned check.

CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS

Overpayments of \$5 or less will not be refunded.

All Trophies must be claimed at the show. If not, they revert back to the property of the show giving club. NO TROPHIES will be mailed. The show giving club reserves the right to substitute trophies with ones of equal or greater value.

The Greater St. Louis Shetland Sheepdog Club does not agree to arbitrate claims as set forth on the official AKC Entry Form for this event.

All persons attending this dog show hereby waive any claim for damages against Greater St. Louis Shetland Sheepdog Club or its members, in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation.

The show giving club, the Show Secretary, the facilities owner, their agents, employees, etc. assume no responsibility for any loss, damage or injury sustained by spectators, exhibitors, handlers, their employees or children, etc. or to any of their dogs or property. Entrants and spectators to this show do so entirely at their own risk. **CHILDREN ARE EXPECTED TO BE UNDER THE CONTROL OF THEIR PARENTS OR GUARDIAN AT ALL TIMES.**

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Additionally, the Greater St. Louis Shetland Sheepdog Club recommends that all exhibitors carry a vaccination record for each individual dog including a notation on current rabies vaccination.

No dogs may be left in the building overnight.
