 Rally classes with jumps will be run as follows. Friday (both trials): Small to tall. Saturday (both trials): Tall to small. Sunday: Small to tall.
 The tall-to-small run order will be accomplished by having the dogs show in reverse catalog order.
 Every effort will be made to accommodate handlers with multiple dogs in the same class.

All entries must be submitted on official AKC entry forms, one dog per entry form. Photocopies of entry forms without the AKC Agreement are not acceptable. Unsigned, incomplete, or illegible entries are not acceptable.

If you would like confirmation that your entry was received before the trial has closed, please include your email address or enclose a self-addressed stamped postcard.

Entries cannot be changed once the trial has closed. **Please check your entries!**

Dogs Eligible to Enter

This trial is open to all dogs six (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number, or are approved Foundation Stock Service (FSS) breeds.

Dogs with a PAL/ILP number or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Dogs should be physically sound. Dogs that are blind or deaf, bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance are not eligible to compete. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Rules Applying to Registration and Discipline for the listing of registerable breeds that may participate.

Wherever the word "dog" is used in these regulations, it includes both sexes.

Waiting List

The trial will have a waiting list in the event the limits are reached prior to closing.

Transfers

Transfers will be allowed according to AKC Regulations, provided that the written request is received at least 30 minutes prior to the start of the trial.

Notice to Exhibitors

The safety of the dogs is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all exercises safely.

Missouri Rhineland Kennel Club may cancel this event in extreme weather conditions.

Entry fees will not be refunded if the trials cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.

Since bitches in season are not allowed to compete in AKC Obedience or Rally Trials, the club will refund all but \$5.00 of the entry fee per day for bitches unable to compete for that reason. The Trial Secretary must receive written notification from a veterinarian of such a claim for refund by letter hand-delivered, emailed, or postmarked before the trial commences.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

Exhibitors are responsible for being ready for judging when called to the ring. The judge need not wait for any dog holding up a class. Missouri Rhineland Kennel Club has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.

Entries must be made on Official AKC entry forms or copies and must include the signed Agreement and Rules. Junior Handlers must complete back of form.

Include only AKC titles on entries.

All owners of mixed breed dogs must first obtain an AKC Canine Partners listing number before they may enter an AKC event. The dog's breed name should be entered as "All American Dog". The dog's listing number must be entered on the entry form and "AKC No." checked.

Owners are responsible for errors in making out entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date. No refunds for duplicate entries.

Dogs under 6 months of age are not permitted on the show grounds of AKC events.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites and any communicable diseases and have appropriate vaccinations.

Returned checks do not constitute a valid entry fee. There is a \$25 returned check fee.

No refunds will be issued for overpayments of less than \$10.

Exhibitors are responsible for cleaning up after their dog(s) at the show site and at all hotels, motels, and campgrounds where they are staying while competing in these trials.

Missouri Rhineland Kennel Club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

Missouri Rhineland Kennel Club, its Board and Members, and Nestlé Purina Farms and its employees will not be liable for any loss or injury which may be sustained through disappearance, loss, theft, communicable disease, parasites, injury and/or death of dogs entered in this event.

NO SMOKING or VAPING is permitted in Purina Event Center.

Weapons of any kind, illegal drugs and fireworks are not permitted on the premises.

The arena is air-conditioned with indoor restrooms.

Please bring crates and water for your dogs and clean up supplies. Ex-pens are permitted.

ALL CRATES MUST BE ON A MAT.

All dogs must be on leash or crated at all times except when in the ring. Warm-up must be done on lead.

No Flexis, prong collars or electronic collars allowed.

Random Reward Classes

Random Reward Novice (R/R Novice)

The Random Reward Novice class is for any dog that is capable of performing the Novice exercises and that is eligible under the Obedience Regulations to complete in AKC events. No title is required to enter, and handlers may enter more than one dog. Dogs in this class may be handled by the owner or any other person, and may be entered in another class or classes. The R/R Novice exercises will be performed as in the regular Novice class, except that verbal praise during the exercises is encouraged and not penalized. "Good," "yes", "nice", "super", "great", "atta boy" are some examples of praise that would be allowed. Handlers may give additional commands and encouragement without being penalized. Handlers will not be allowed to hold up a class with excessive encouragements and Judges have the option to end any exercise.

Random Reward Open (R/R Open)

The Random Reward Open class is for any dog that is capable of performing the Open exercises and that is eligible under the Obedience Regulations to complete in AKC events. No title is required to enter, and handlers may enter more than one dog. Dogs in this class may be handled by the owner or any other person, and may be entered in another class or classes. The R/R Open exercises will be performed as in the regular Open A class, except that verbal praise during the exercises is encouraged and not penalized. "Good," "yes", "nice", "super", "great", "atta boy" are some examples of praise that would be allowed. Handlers may give additional commands and encouragement without being penalized. Handlers will not be allowed to hold up a class with excessive encouragements and Judges have the option to end any exercise.

Random Reward Open (R/R Utility)

The Random Reward Utility class is for any dog that is capable of performing the Utility exercises and that is eligible under the Obedience Regulations to complete in AKC events. No title is required to enter, and handlers may enter more than one dog. Dogs in this class may be handled by the owner or any other person, and may be entered in another class or classes. The R/R Open exercises will be performed as in the regular Utility A class, except that verbal praise during the exercises is encouraged and not penalized. "Good," "yes", "nice", "super", "great", "atta boy" are some examples of praise that would be allowed. Handlers may give additional commands and encouragement without being penalized. Handlers will not be allowed to hold up a class with excessive encouragements and Judges have the option to end any exercise.

For each of the above classes the handler may choose to

- A) Skip one exercise or
- B) Do that exercise but the handler may now be allowed to leave position anywhere in that exercise, go toward the dog and reward with a toy. (Toys may not make noise or be an item that would roll into another ring.)

When checking in, the handler must inform the judge or steward which exercise will be selected to skip or selected to go and reward the dog.

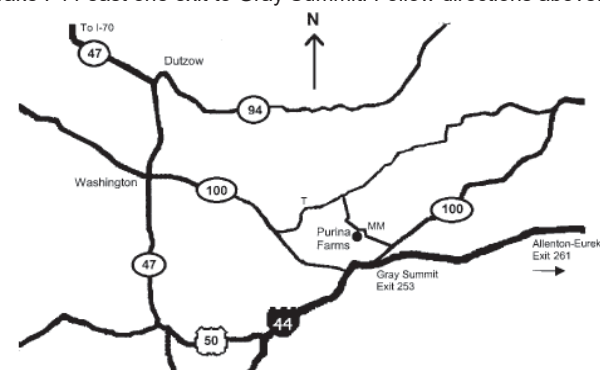
All exhibitors must be responsible for cleaning up after their dogs on the motel, RV and trial grounds. Motels require that dogs be crated when unattended. Any damages to motels, RV sites or the trial site can result in disciplinary action by the Event Committee. It is expected that exhibitors will clean up immediately after their own dogs and strongly encourage others to do the same.

All owners/exhibitors should be aware that the entire motel grounds and RV sites are considered within the trial grounds. You will be responsible for all damage to your room/site and may be subject to disciplinary action in accordance with the rules of the AKC. Any abuse of the grounds will be brought to the attention of the trial-giving club and its Event Committee. Any exhibitor's entries may be refused for previous misuse of the motel or RV facilities. This is an AKC supported measure.

Directions

From North/East/South: Take I-44 to Gray Summit/Hwy 100 Exit 253. Turn east on Hwy 100. After approximately 0.5 mile, turn left on MM at gas station. Entrance to Purina Farms is approximately 0.5 mile on left, just past the herding field.
