

It is distinctly understood that exhibitors will exercise control and restraint over their children on the days of the show. Any exhibitor whose dog and/or child creates unnecessary disturbances or repeatedly engages in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such cases, no refund of any fees paid will be made.
- No filming of this event, except for one's personal use, unless cleared by the Show Committee. By attending or participating in this event, all persons grant the show-giving club the right to photograph, televise, videotape, audiotape, or otherwise use their likeness, voice, or dog without further release or consent. All rights to televise, videotape, advertise, photograph, promote or otherwise exploit this event are vested in the Club, or in persons to whom assignments of such rights have been made in writing by the Club. All persons and animals on the showgrounds at any time while the shows are in progress, do by attending these shows or participating therein, grant to the Club the right to photograph, televise, videotape, audiotape or otherwise use their likeness and voice in any manner without further release or consent.
- Dogs must be ready for judging and need be present only for scheduled judging. Dogs will be released if not needed for further judging. The Club will not be responsible or obligated to furnish any service for notifying exhibitors or their agents of judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging ring.
- All dogs must be held on leash or confined to their crates at all times except when in the ring being judged, in an exercise pen or when in the designated warm-up area.
- No un-entered dogs or puppies under six (4) months of age are permitted at the show site. Dogs are allowed in rings during judging only.
