"After Closing" Waiting List

This trial has an after-closing waiting list for Saturday and Sunday. The waiting list will be active until its deadline — Monday, August 19, 6:00 pm CDT. Any dogs that are entered in these trials and pulled before the waiting list deadline will be replaced, if possible, by dogs in order on the waiting list, and the exhibitor will be reimbursed in full. If a dog is pulled but cannot be replaced, the exhibitor will not receive a refund and the dog will be considered absent for the trials. Any exhibitor on the after-closing waiting list who does not get in the trial by August 19 will receive a full refund for the runs that did not get in.

Move-ups

For the Friday trial: MOVE-UPS close at 6:00 pm CDT, Monday, August 19. Move-ups may be sent by regular mail or email to the Trial Secretary. If an email address is provided with your entry, an email confirmation of the move-up will be sent.

For the Saturday and Sunday trials: MOVE-UPS close 30 minutes after the end of the trial on Friday and Saturday respectively and must be submitted at the trial.

Electronic Timing

Electronic timing will be used at these trials.

AKC Height Cards

There will be VMOs at these trials to measure dogs for AKC Height Cards.

Prizes and Awards

Ribbons will be awarded to First Place through Fourth Place in each jump height in each class. Qualifying ribbons will be awarded to all dogs receiving a qualifying score. Dogs must qualify to receive placement ribbons.

A jump bar, MACH rosette and tote bag will be awarded to any handler finishing a MACH title at these trials. A jump bar, PACH rosette and tote bag will be awarded to any handler finishing a PACH title at these trials. A jump bar and PAX rosette will be awarded to any handler finishing a PAX title at these trials. Dogs earning a qualifying score will receive a toy (\$2 value).

Trial Information

The building is available for set up at 8:00 am on Friday, August 23. There is NO SETUP on Thursday.

Trial hours are 8:30 am to 30 minutes after completion of judging on Friday and 7:00 am to 30 minutes after completion of judging on Saturday and Sunday.

Ring size: 80' x 125'.

Please bring crates for your dogs and clean up supplies. All crates must be on a waterproof tarp to protect the soccer turf.

Crating space is limited. Xpens permitted for multiple dogs only (2 large or 3+ small).

Food and drink service is available at the trial site. NO OUTSIDE FOOD is permitted. A small cooler for dog treats is allowed.

Notice to Exhibitors

- The <u>safety of the dogs</u> is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all obstacles safely.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.
- Tri-County Agility Club of Missouri may cancel this event in extreme weather conditions.
- Entry fees will not be refunded if the trials cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
- Since <u>bitches in season</u> are not allowed to compete in AKC Agility Trials, the club will refund all but \$5.00 of the entry fee per day for bitches unable to compete for that reason. The Trial Secretary must receive <u>written notification</u> of such a claim for refund by letter hand-delivered, emailed, or postmarked before the trial commences.
- The club will refund all but \$10.00 of the entry fee per day for injured or ill dogs. Written request for a refund must be made to the Trial Secretary prior to the start of the first trial day and a veterinarian's letter must be provided within one week of the trial.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.
- All dogs must be on leash or crated at all times except when in the ring or when in the designated agility warm-up area.
- Exhibitors are responsible for being at the ring gate when it is their turn to run. The judge need not wait for any dog holding up a class. Tri-County Agility Club of Missouri has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.
- Entries must be made on Official AKC entry forms or copies, must be completed in full as described in the Regulations for Agility Trials, and <u>must include the signed Agreement and Rules</u>. <u>Junior Handlers</u> must enter their JH# and complete back of form.
- Include only AKC titles on entries.
- Owners are responsible for errors in making out entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date. No refunds for duplicate entries.
- ${\bf Dogs\ under\ 4\ months\ of\ age\ are\ not\ permitted\ on\ the\ show\ grounds\ of\ AKC\ Agility\ Trials.}$
- Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites and any communicable diseases and have appropriate vaccinations.
- Tri-County Agility Club of Missouri does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.
- Returned checks do not constitute a valid entry fee. There is a \$10 returned check fee.
- No refunds will be issued for overpayment of less than \$12.
- Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement.
