Dogs Eligible to Enter

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/ Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number, or are approved Foundation Stock Service (FSS) breeds.

Dogs with a PAL/ILP number or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Dogs should be physically sound. Dogs that are blind, bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance are not eligible to compete. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Rules Applying to Registration and Discipline for the listing of registerable breeds that may participate.

Wherever the word "dog" is used in these regulations, it includes both sexes.

Tentative Running Order/Start Times

Start Times

All days Judging will start at 8:00 am. Walkthrough schedule will be posted after closing.

<u>Move-ups</u>

For the Friday trial: MOVE-UPS close at 6:00 pm CDT, Monday, June 22. Move-ups may be sent by regular mail or email to the Trial Secretary. If an email address is provided with your entry, an email confirmation of the move-up will be sent.

For the Saturday and Sunday trials: MOVE-UPS close 30 minutes after the end of the trial on Friday and Saturday respectively and must be submitted at the trial. Mailed/emailed moveups close at 6:00 pm CDT, Monday, June 22.

Change of Entry

As described in Chapter 1, Section 21 of the Regulations for Agility Trials, a dog which is entered in a Novice A class for which it is not eligible may be moved to Novice B. In addition, if notification has been received in writing from the AKC after closing that a dog is not eligible for a class entered, the dog may be moved to the correct class. The request for the move must be made at least 30 minutes prior to the start of the trial. If a VMO or Field Representative at a trial measures a dog into a height other than what they entered, the entry may be changed from Regular to Preferred or from Preferred to Regular, as long as the dog has not run any classes that day. If the dog has already run, the change may be made for the next trial day(s). The exhibitor must provide the Trial Secretary the AKC Agility Measurement Form when requesting the class change.

Trial Information

Trial hours are 7:00 am to 30 minutes after completion of the trial. The building is climate-controlled. Dogs may not be left in the building overnight. Electronic timing will be used at these trials. Setup time will be announced after closing.

Crate & Chair Information

Please bring crates and water for your dogs.

Crate mats are required under all crates. For the safety of everyone, all mats must be completely under your crates.

No personal chairs will be allowed in the building.

CORONAVIRUS * * Information You Need to Know * *

FOR ENTRY TO BE VALID, THE SIGNED COVID WAIVER MUST BE INCLUDED WITH THE ENTRY. The waiver is published in this premium and available at http://www.labtestedsecretary.com on the June Triune page. **Owners** and **Handlers** must submit a signed waiver.

With the changing guidelines that are being required due to the Coronavirus, we are making the following revisions with the assumption that we will be limited to having 50 people in the building at one time. Of course, all our extra work and planning hinge on the hope that Madison County will be open for this event. If it is not open, we will again cancel at the last minute and shred checks.

Triune Agility Club of Southwest Illinois and Triune Canine Training and Event Center cannot guarantee your safety and good health. But we are making many adjustments to make this trial as safe as possible. We realize that some of these adjustments will be too much for some people and not enough for others. This is our plan for moving forward with this trial, and you can make your own decision on what is best for you. Remember, despite all the plans we put in place, you still need to be aware of the basics: WASH YOUR HANDS AND WASH THEM OFTEN AND MAINTAIN SOCIAL DISTANCING.

We are going to limit the trial to 300 runs per day. We will have the same running order all three days: Tall to Small; Open JWW - Novice JWW - Novice Standard - Open Standard - Time to Beat - Master/Excellent Standard - Master/Excellent JWW. After the closing date, we will schedule times for exhibitors to walk/run.

There will be ONE entrance to the building in the back and two exits: one in the front and one on the side in back.

Exhibitors will not be allowed in the building unless it is their scheduled walk through and running time. However, there will be breaks between each class for course build during which time people can come in and get their dogs in and out of crates and use the restroom. This will be done with the limit of people in mind.

Only workers and those in the group running will be allowed to stay in the building. Only the owner/co-owner or handler of the dog in the group will be allowed in the building. After the run, you will need to leave the building so the next handlers will be allowed in. We will have someone at the door, helping keep track of the number of people inside.

Crating will be preassigned. A signup link will be sent out at a later time for the handler to block an area. There will be no crating along the long wall at this trial. Crate mats must be under all crates in all areas. If you are leaving a dog inside, you will need to fill out a crate tag with dog's name and your phone number and leave it on the crate. No unentered dogs will be allowed a crating space unless they fit in the exhibitor's existing assigned crating area or there are unused spaces. No personal chairs may be brought into the building. There will be facility chairs in one area for use that will be cleaned in between groups.

We will be using the old style of entry and exit from the ring — the double fence (chute). There will be NO SWING GATE. Practice your recalls.

Masks (which you must provide) will be required while in the building with the exception that you may choose not to wear your mask while waiting at gate or during your run. You will need to put the mask back on after your run. Masks will be optional for the scribe, timer, ring crew, secretary and judge once they are in position. Hand sanitizer will be provided by the club and be in stations around the building. BUT REMEMBER, WASH YOUR HANDS AND MAINTAIN SOCIAL DISTANCING.

There will be a 6' distance boundary around the gate steward, timer, scribe and secretary. Course builders will be limited to those who have signed up. They must wear masks and use gloves while setting courses. Extra bars will be available and will be changed out so that the used bars may be disinfected during worker change. The leash runner will have a grabber to move the leash; the grabber will be cleaned between workers.

No printed course copies will be distributed. We will have a few posted outside so you can take a picture of them. The trial secretary will also post them at http://www.labtestedsecretary. com each morning and notify everyone by email. She will also post the running order, judge's briefing, trial chair's briefing and results. There will be no group judge's briefing, except for the Novice classes to answer any of their questions. The general information will be posted. Our plan is to do a FACEBOOK live feed during the show, so you can watch. Announcements will be made throughout the day to keep you updated.

If you are parked back behind the building, you will not be allowed to run your car engine while there. If you want to do this, you will need to park in the front parking lot. Exhibitors will be waiting there for their turns to go into the building and we do not want the exhaust hindering their ability to do so.

NO CONCESSIONS OR HOSPITALITY WILL BE PROVIDED. PLEASE BE PREPARED AND BRING YOUR OWN. This includes drinks. There are also many restaurants within 5 minutes for carry out.

Our awards chairperson will prepare your ribbon (with gloves on) if you would like to take your award, anytime 30 minutes after the completion of the class.

There will be no vendors at the trial.

People who are not feeling well and contact trial secretary before the start of the trial will be given the same refund as an injured dog. No doctor's note is required. We will automatically cancel the following days runs also. You will receive that same refund for each of the remaining days to get over being sick. PLEASE, STAY HOME AND KEEP EVERYONE SAFE. People who are visibly sick and attend the trial may be asked to leave with NO REFUND.

The trial committee has the right and the ability to amend the premium as to the changing guidelines due to COVID-19 (Coronavirus). YES, LOTS OF CHANGES AND RULES, BUT WE ARE TRYING TO KEEP AS SAFE AN ENVIRONMENT AS POSSIBLE WHILE STILL GETTING TO RUN OUR DOGS.

Notice to Exhibitors

- The <u>safety of the dogs</u> is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all obstacles safely.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.

Triune Agility Club of Southwest Illinois may cancel this event in extreme weather conditions.

- Entry fees will not be refunded if the trials cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
- Since <u>bitches in season</u> are not allowed to compete in AKC Agility Trials, the club will refund all but \$15.00 of the entry fee per day for bitches unable to compete for that reason. The club will refund all but \$15.00 of the entry fee per day for <u>injured dogs</u>. In both cases, written request for a refund must be made to the Trial Secretary prior to the start of the first trial day and a veterinarian's letter must be provided.
- THE CLUB WILL ALSO REFUND ALL BUT \$15.00 OF THE ENTRY FEE PER DAY FOR THAT DAY AND THE REST OF THE WEEKEND FOR SICK HANDLERS. YOU MUST CONTACT THE SECRETARY BY EMAIL BEFORE THE START OF YOUR FIRST CLASS OF THE DAY. NO DOCTORS EXCUSE NEEDED. IF YOU ARE SICK, STAY HOME!!!!!
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.
- <u>All dogs must be on leash or crated</u> at all times except when in the ring or when in the designated agility warm-up area.
- Exhibitors are responsible for being at the ring gate when it is their turn to run. The judge need not wait for any dog holding up a class. Triune Agility Club of Southwest Illinois has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.
- Entries must be made on Official AKC entry forms or copies and <u>must include the signed</u> <u>Agreement and Rules</u>. <u>Junior Handlers</u> must enter their JH# and complete back of form.
- All owners of mixed breed dogs must first obtain an AKC Canine Partners listing number before they may enter an AKC Agility event. The dog's breed name should be entered as "All American Dog". The dog's listing number must be entered on the entry form and "AKC No." checked.
- <u>Owners are responsible for errors in making out entry forms</u>, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. <u>Errors in entries made by the exhibitor cannot be corrected after the closing date</u>. No refunds for duplicate entries.

Dogs under 4 months of age are not permitted on the show grounds of AKC Agility Trials.

- Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites and any communicable diseases and have appropriate vaccinations.
- Triune Agility Club of Southwest Illinois does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.
- Returned checks do not constitute a valid entry fee. There is a <u>\$25 returned check fee</u>. No refunds will be issued for overpayment of less than \$10.

Checks for cancelled or unacceptable entries will be shredded. No check will be returned. Flexi-Leads are not allowed in the building. X-Pens are not allowed in the building.

- Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement.
- All exhibitors are required to observe the policies of the Triune Training and Event Center. The policies are published at http://triunecanine.com/event-center/event-center-policies/.

Changes Effective January 1, 2020

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A **separate entry form must be submitted** when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

Fix and Go On (FNG)

As of January 1, 2020, Fix and Go On will be offered on a one-year pilot basis in order to give AKC time to evaluate its impact. FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle and then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score.

Fix and Go On is not pre-entered; rather, it occurs during the course of the run.

For Exhbition Only (FEO)

FEO is not offered at this trial.

Prizes and Awards

Ribbons will be awarded to First Place through Fourth Place in each jump height in each class. Qualifying ribbons will be awarded to all dogs receiving a qualifying score. Dogs must qualify to receive placement rosettes.

A new title rosette will be awarded to any dog finishing a title at these trials. Dogs qualifying in both Master Standard and Master JWW in the same trial will receive a "Double-Q" award (value \$3.00-\$3.85). Dogs qualifying in Master Standard, Master JWW and Master FAST in the same trial will receive a "Triple-Q" award (value \$7.00).

INSTRUCTIONS

Handlers whose dogs measure into the 8" through 20" regular jump height divisions may opt to enter in a higher or 24-choice height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs who measure into the 24" regular jump height division may not enter 24-choice. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine Partners Program[™] may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?


